COURSE INFORMATION

The Level 3 Training Assessment & Quality Assurance (TAQA) Award will cover all essentials, principles and practices of training assessment and quality assurance, including assessing competence and achievement. This qualification can help you to progress your career as a qualified assessor or trainer and will enable you to assess vocational qualifications. This qualification is entirely a private course and therefore no funding is available. A minimum of 2 'in house' learners are required to undertake this course

This qualification could be appropriate for jobs such as:

- Qualified Assessor
- Trainer

Duration of the Course – 9 to 12 months (course dependant)

TAQA Level 3 Units

- Understanding the Principles and Practices of Assessment
- Assess Occupational Competence in the Work Environment
- Assess Vocational Skills, Knowledge and Understanding

A UKTD representative/tutor will help you choose the most appropriate course to match your current job role.

Course Structure

To achieve the Award in Assessing competence in the work environment TAQA Level 3, Candidates must achieve 9 credits in total; 3 credits from the knowledge unit and 6 credits from the practical unit.

To achieve the Award in Assessing Vocationally Related Achievement TAQA Level 3, Candidates must achieve 9 credits in total; 3 credits from the knowledge unit and 6 credits from the practical vocationally related unit.

To achieve the **Certificate in Assessing Vocational Achievement TAQA (CAVA) Level 3**, Candidates must achieve **15** credits in total; **3** credits from the knowledge unit and a total of **12** credits from both the practical units.

Progression

Once you have successfully completed your Level 3 qualification, you may wish to progress to the Level 4 qualification or another qualification appropriate to your personal development i.e. Award in Education and Training Level 3.
